15/134 Highways & Footpaths Matters

- **1. Tremeale Hill:** CC Highways have added request for extension to existing kerbing to program of works, to be reviewed against budget. Waiting for update.
- **2. Speed of cars on B3254:** CC Highways have added to the Speedvisor programme. Clerk has requested deployment date.
- **3. Speed sign in Daw's House**: rectified (seems to be on all the time rather than reacting to speed).
- 4. Tiny Meadows footpath issue regarding area not being adopted by Cornwall Council.Parish Council will check with Land Registry.Page 16

- 5. Verges between Pennygillam Roundabout & Daw's House: cutting completed.
- **6. A30 Polyphant to Trebursye Pavement Renewal Scheme work in 2017.** Meeting held in July received update from Highways England. Clerk to request Highways England present all the various schemes to the Parish Council at a future meeting.
- **7. Grit bins:** request from residents of Petherwin Water. Cllr Neil Burden suggested the Cornwall Councillor Community Grant Scheme. It was also suggested that Kennards House needs a grit bin, so Clerk to apply for 2 bins & grit supply.

15/135 Current & Ongoing Business

- **1. New pensions regulations:** Pension options to be sent to the Clerk from the Parish Council by the end of the year. The first staging date is 1st February 2016.
- 2. Victory in Europe Day: Invoices to be paid for printing, Cllr Parsons to update. Deferred.
- **3. Noticeboards:** Clerk to contact Rosemary Stone for Cornwall Community Chest application form, in order to upgrade parish noticeboards.
- **4. SPED (Defibrillator):** with the Parish Council's permission, SPED are painting the toilet wall prior to a SPED-funded noticeboard being put up (featuring emergency information).
- 5. Standing Orders: Review is on-going.
- **6.** Accountability framework: new Transparency Code for smaller authorities: meeting with Clerk, Roger Pyke & Cllr Parsons to discuss the use of the Village Website to be arranged, but everything is agreed in principle.
- **7. Skateboard Event:** The Clerk has applied for grant aid from organisations. Date of event to be finalised.
- **8. CALC training courses:** Freedom of Information & Data Protection course on 23/9/15 has been cancelled. Cllr D Rogers is unable to attend the Budget Setting & Precept course on 30/9/15, so Cllr M Screech agreed to attend instead. Clerk to advise CALC & send course details to Cllr Screech.
- **9. Discontinuation of paper planning applications.** Delayed until January 2016. Need to allow for this when setting the precept, and check re Cornwall Council grants available to run the paperless system.
- **10. Minute book(s) prior to 1920 missing.** Cornwall Records Office (CRO) appear not to hold them. Clerk to put a request on the Parish Website & in the November Parish Magazine issue, asking if any parishioner knows of their whereabouts.
- **11. Wreath for Remembrance Day, November.** Clerk to check with Fran Dennison. Finalise details at October meeting.

15/136 New business: there was none.

15/137 Cornwall Councillors Report: Cllr Neil Burden gave some useful information during the meeting on available grants. He advised that the government may be capping Parish Council precepts at 2% increase.
