12	A30/B3257 Junction at Bodmin Services (Plusha). Cllr Barlow reported back on the meeting which was held at Altunan Village Hall on January 28 th 2026, and slides from the meeting had been circulated beforehand. Cllr Barlow reiterated at the meeting South Petherwin Parish Council's position that grade separation is the preferred option (Clerk to write and reconfirm this). Ongoing plans for the area to be discussed, as Cornwall Council will not adopt the walkway. b) School Hill resurfacing will be carried out in the spring. c) Issues with traffic diverted through village on 19/12/25: damage to road. Highways have been notified. d) Issues with flooding on B3254 near Petherwin Water & Slate Quarry. Highways have been notified. e) Trees covering streetlights on road to Daws House. Contact Highways. f) Branch down opposite Trelinnoe Close. Highways have been notified. g) Salt bin top up. Clerk to contact Highways regarding cost of topping up all salt bins. Proposed by Cllr Middleton, seconded by Cllr Rowse, with all in favour. h) LMP 2026/27. The council agreed to accept Cornwall Council's offer for cutting vegetation along public rights of way.
