- 9 Highways & Footpaths Matters
  - 1. Tremeale Hill: CC Highways work on extension of existing kerbing from 2/11.
  - 2. Speed of cars on B3254: CC Highways covert speed monitoring device is in operation.
  - 3. Tiny Meadows footpath issue regarding area not being adopted by Cornwall Council.
  - **4.** A30 Polyphant to Trebursye Pavement Renewal Scheme work & Plusha Junction proposals. Nigel Dyson (Highways England) &/or David Phillips (Cormac) will attend the Parish Council meeting to explain the different schemes in more detail.
  - **5. Grit bins:** ordering grit bins for use at Petherwin Water & Kennards House. Highways Working Group to discuss placement with Highways & issues regarding liability, training & policy.
  - **6. Traffic speeding through Tregadillett village:** problems with cars & farm vehicles speeding & causing hazards in the village. Councillors to attend next meeting at St. Thomas Parish Council.
  - **7.** Concern re. access out of School Hill on to the main road, especially due to extra use from shop. Discussing with Highways.
  - **8. Overgrown footpath into Tregadillett**. Clerk to show Councillors exact location on map in order to ascertain next steps.
  - **9. South West Ambulances** have been attempting to use the track to Trebursye Manor, which isn't a right of way. Clerk to contact SW Ambulances.

10. Footpath sign at other end of this track also missing. Clerk has contacted Highways.

#### 10 Current & ongoing business

- **1. New pensions regulations:** Pension options to be sent to the Clerk from the Parish Council by the end of the year.
- **2. Noticeboards**: Clerk to obtain quotes for repairs/upgrades to the boards prior to applying to the Ruth Burden Fund for £200 towards the repairs.
- **3. SPED (South Petherwin Emergency Defibrillator):** ownership of the SPED-funded Defibrillator/Emergency noticeboard to be given to the Parish Council.
- 4. Standing Orders: Review is on-going.
- **5.** Accountability framework: new Transparency Code for smaller authorities: fund for small authorities to help meet the costs of the Transparency Code to be applied to for help towards the costs of the Village Website.
- 6. **Discontinuation of paper planning applications.** Delayed until January 2016, Parish Council to request an extension to 1<sup>st</sup> April 2016, as Clerk not attending a workshop until 18<sup>th</sup> January 2016. Clerk also to request a simplification of the ease of use of the Planning Portal.
- **7. Minute book(s) prior to 1920 missing.** Cornwall Records Office (CRO) appear not to hold them. Clerk has put a request on the Parish Website & will also put one in the November Parish Magazine issue, asking if any parishioner knows of their whereabouts.
- **8.** Wreath for Remembrance Day, November. The wreath is being organised by the village church this year, and the Parish Council will reimburse them for the costs, as in previous years.
